



SUMMARY OF RESPONSES CONCERNING ADVICE ON US INSTITUTIONS IN SCHOOL OF RECORD PARTNERSHIPS WITH INSTITUTIONS ABROAD OR THROUGH THIRD PARTY PROVIDERS

1. Most common caveat was to be careful with US accreditation at the institutional and academic discipline levels.
2. I did have a phone conversation where the partnership was well in place but the partnership was with a US-based organization offering programs outside of the US. Very complex and successful relationship has developed.

Also in 2001 "The American Council on Education (ACE), the Council on Higher Education Accreditation (CHEA), and the American Association of Collegiate Registrars and Admissions Officers (AACRAO) jointly released an updated Joint Statement on the Transfer and Award of Credit as a framework to revisit increasingly complex transferability issues."

"Joint Statement on the Transfer and Award of Credit - The following set of guidelines has been developed by the three national associations whose member institutions are directly involved in the transfer and award of academic credit: the American Association of Collegiate Registrars and Admissions Officers, the American Council on Education, and the Council for Higher Education Accreditation. The need for such a statement came from an awareness of the growing complexity of transfer policies and practices, which have been brought about, in part, by the changing nature of postsecondary education. With increasing frequency, students are pursuing their education in a variety of institutional and extrainstitutional settings. Social equity and the intelligent use of resources require that validated learning be recognized wherever it takes place..."

7. One response noted that the Forum on Education Abroad has a working group discussing this as well and that they may have some guidelines to propose in the near future.

In the end from all the feedback it was clear that there is strong interest in this but not much in the way of guidelines in this area beyond that offered through US accreditation agencies and professional organizations such as AACRAO. Clearly there are School of Record partnerships that exist in one form or another and that time and experience has been beneficial. Perhaps trying today to implement something of this nature might be an increasing challenge given the potential for more institutions/agencies to be involved from the outset.

From all these discussions it was clear that there are many issues that need to be addressed from "accreditation level certification" of those teaching the courses proper to the administration of the host institution (abroad) and the academic content as well financial arrangements. Ultimately it appears that increasingly the US institutions accrediting agency and any academic discipline accreditation agency will be (if not already) involved either up front, during or after the fact.
